APLAC Mutual Recognition Arrangement

The APLAC MRA consists of 39 signatories from 24 economies and one multieconomy accreditation body representing 7 economies, and includes 37 in testing, 29 in calibration, 19 in inspection, 18 in ISO 15189, 15 in RMP and 14 in PTP. Fifth APLAC PAC Joint General Assembly

The fifth APLAC PAC Joint General Assembly was held on 7th June 2018. The Joint General Assembly agenda covered the reporting on the joint meetings held during the week, reports from the regions, and discussion on the draft APAC Constitution, draft APAC fee model, draft APAC budget and the progress made by the Working Groups in creating the documentation needed for the new regional entity.



24th APLAC General Assembly

The 24th APLAC General Assembly was held on 8th June 2018 and the main outcomes arising from that meeting were as follows:

- elections of APLAC office bearers (for details see below);
- adoption of the name of Asia Pacific Accreditation Cooperation Incorporated (APAC) as the new name for APLAC, with effect from the date the new APAC Constitution has been registered by the Registrar of Incorporated Societies, New Zealand;
- adoption of the APAC Constitution to replace the current APLAC Constitution;
- endorsement of funding for evaluator training on the revised ISO/IEC 17011 standard;
- endorsement of funding for ISO/IEC 17025 and ISO/IEC 17020 training courses in the second half of 2018;
- endorsement of funding for two joint APLAC APMP proficiency testing schemes due for commencement in the second half of 2018; and
- endorsement of the APLAC budget for July to December 2018.

The MRA Council Evaluator Training Working Group has held an evaluator training course on ISO/IEC 17011:2017 from 10 to 11 September 2018 in Frederick, United States of America.
