INTRODUCTION

ASEAN Cooperation on Legal Metrology is aimed at facilitating the removal of technical barriers to trade associated with legal metrology in order to contribute in the realization of the ASEAN Economic Community.

The ASEAN Legal Metrology Authorities have joined together through the ASEAN Consultative Committee for Standards and Quality (ACCSQ) Working Group on Legal Metrology (ACCSQ WG 3) to align legal metrology requirements amongst ASEAN Member States (AMS) and strengthen ASEAN cooperation at relevant international fora.

(2) STRENGTHENING QUALITY INFRASTRUCTURE IN ASEAN 2019-2021

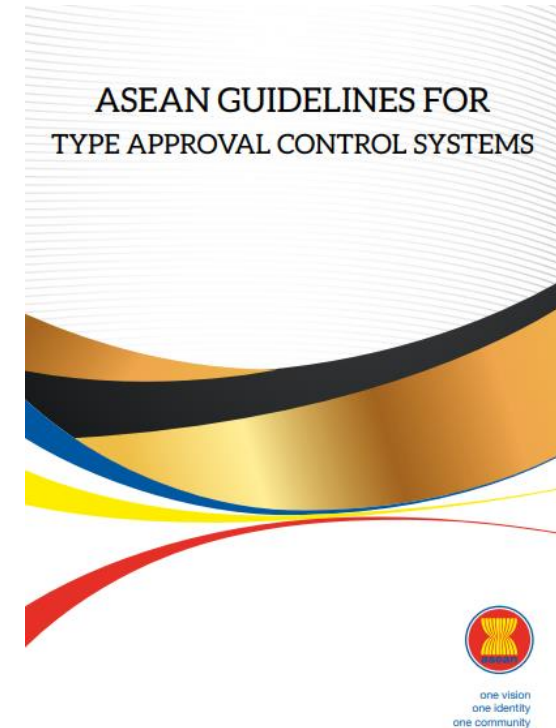
- a study on the implementation of ACRPPP in AMS
